CHAIRPERSON MILLER: The next case is 14-PRO-00020, Stadium located at 2127 Queens Chapel Road, N.E., License No. 82005, in ANC-5C. This also is a Protest (Status) Hearing case.

MS. TODD: Good morning, Karen Todd on behalf of the applicant.

CHAIRPERSON MILLER: Good morning.

MS. BUTLER: Good morning, Karla Butler representing ANC-5C.

CHAIRPERSON MILLER: Okay. If you have any preliminary issues you want to bring to our attention, you can. Otherwise, I'm going to set the case for hearing and read you the instructions for the Protest Hearing.

MS. TODD: No, there is no preliminary issues.

CHAIRPERSON MILLER: Okay. Okay. And I'm sorry, you're Karla Butler?

MS. BUTLER: Karla Butler.

1 CHAIRPERSON MILLER: And you are
2 designated representative for both ANC-5C and
3 Group of 98?

4 MS. BUTLER: Correct.

5 CHAIRPERSON MILLER: Okay. All
6 right. I just want to read you just a few key
7 points to keep in mind with respect to a
8 Protest Hearing.

9 The purpose of the Protest Hearing
10 is to determine the appropriateness of the
11 establishment in the section of the District
12 where the establishment is located. We
13 require that you file a Protest Information
14 Form and an Exhibit Form with the underlying
15 exhibits seven days ahead of the hearing and
16 to serve those as well on any opposing party.

17 They are critical to the focus of
18 the hearing and to putting each of the parties
19 on notice as to the issues in the case, so
20 that everyone is prepared to go forward. If
21 we don't receive a copy of your PIF, it's
22 possible that your application or your protest

1 may be subject to dismissal. So pay attention
2 to those seven days.

3 If we don't receive a copy of the
4 Exhibit Form and the exhibits themselves, the
5 exhibits may be excluded from the record upon
6 a finding that the opposing party has been
7 prejudiced or no good cause for the failure to
8 submit has been shown.

9 Likewise, witnesses other than a
10 party who are also supposed to be identified
11 on that PIF Form, they also are subject to
12 exclusion if not identified.

13 You should have copies of all
14 those forms. If you don't, contact Tesha
15 Anderson. Her number is 442-6492. And if you
16 have any questions between now and the
17 hearing, feel free to contact her or contact
18 Martha Jenkins, our General Counsel.

19 Your Protest Hearing date is July
20 23, 2014 at 4:30 p.m. Okay. Any questions?
