## **Meeting Notes**

#### I. WELCOME AND AGENDA REVIEW

Synina Pugh (ICH, ERSO Advisor) opened the meeting, welcomed attendees, and started the recording with a reminder about the ICH recording conventions detailed on slide 3.

Synina covered housekeeping items slides 5-6 including:

Synina, asked co-chairs Tony Newman (Deputy FSA Administrator-Individuals, DHS, and Reginal Black (Co-Director, PFFC) to introduce themselves. Ms. Pugh asked co-chair Reginald Black to provide a review of the meeting agenda.

#### II. SYSTEM CHECK-IN

## A. AIR QUALITY EMERGENCY PLANNING (HSEMA / DHS)

Synina turned the agenda to Corinne Edds (HSEMA )who presented a summary of actions and outcomes from the Hazard Air Quality event on June 7. Please see slides 8-10 for that update.

#### Highlights include:

- HSEMA is tasked with the creation of a Hazardous Air Quality Guide
- Messaging templates are pre-translated and approved for future use
- Continuing with partner collaboration

#### June 7 Operational Shifts included:

- Additional water delivered to LBS and community
- Extra masks provided
- Extended Day Center Hours for Purple Alert
- Reality air quality is going to get worse
- The District is incorporating Air Quality into the Continuity of Operations (COOP) Planning efforts.

- Did people know there was an air quality event?
- Did our staff and consumers understand the shifts in severity?

Given that hot weather impacts air quality, HSEMA will connect with DOEE to determine the best action plan for guidance in air quality planning for clients.

III. DISCUSSION: ENGAGING WITH LAW ENFORCEMENT,

NON-CONGREGATE SHELTERS AND DEVELOPING WINTER-PLAN

### A. HOW TO ENGAGE WITH LAW ENFORCEMENT (MPD)

Captain Jonathan Dorrough (Strategic Change Division, MPD) presented on a pilot program in collaboration with the Department of Behavioral Health (DBH) to stand up a co-response team in the District. The program involves having the following.

- Officers and clinicians riding together in a police vehicle during calls (ride-along).
- Five officers are assigned from MPD. MPD are waiting for DBH clinicians to be assigned to the co-response team.
- Provide active CIO and crisis intervention officers are on the MPD side.
- Melanie Menges (MPD) is partnering with Captain Dorrough on this project.

Out of this and in conversation with the ICH – there is a request to set up an MPD 101 presentation for shelter staff and the co-response teams for DBH. The official presentation will require MPD approval. Below are the four overarching topics for the MPD 101 presentation:

- History / organization of MPD
- How calls are received/dispatched
- How we classify crimes and what's involved in making arrests.
- What happens after a crime occurs whether arrest or no arrest.

- Recommendations for the presentation includes the following:
- Providing guidance on how calls are dispatched.
- Engagement and language on FD-12's
- Providing clarity on dispatch on of co-response versus other teams.
- Provide guidance on when to contact MPD.

#### **B.NON-CONGREGATE SHELTER**

Anthony Newman (DHS) presented on the acquisition of The Aston Building – a non-congregate shelter located in Ward 2, partially funded by HUD.

• Advantages of non-congregate sites

- Who will be served at the Aston (190 Rooms / 2 to a room)
- Low barrier shelter vs. Non-congregate shelter
