

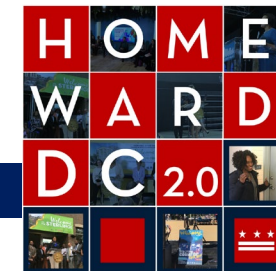

Timeline and Opportunities



❖ Shelter Redevelopment Options

- 1st opportunity (aka NYA Replacement) underway
 - ✓ Are we working to replace beds 1:1? Are we creating a deficit if we don't replace the beds 1:1?
 - ✓ 5-year process in terms of the design of 801: 2017; 801 facility built and occupied: 2022
 - ✓ **Homework:** confirm timeline w/ the facilities team.
 - ✓ Where is the Replacement Site? The current location of the Animal Shelter Site.
 - ✓ **Homework:** how large is the site? What can it accommodate? Are different options for design/buildings a possibility?
- DGS finalizing Architect and Engineer procurement
- Need to get design input and feedback ASAP (July/Aug)
- **Imperative to engage consumers & staff ASAP**

❖ Non-Congregate Shelter

- Potential to leverage HOME ARP funds (\$19M, minus admin likely \$16M)
- HOME ARP Plan (publication date: July 8; public hearing date: July 27; submission to HUD will depend on outcomes of the public hearing process)
- Money will be available as soon as HUD approves the HOME ARP Plan (expected within a month or two of submission to HUD)

❖ Question about the definition of Non-Congregate

- Current models in the District (e.g. PEPV and Valley Place) include hotel-style single or double-occupancy in a bedroom with no shared amenities vs apartment-style single or double-occupancy in a bedroom with shared amenities like kitchenettes and/or living rooms
- **Homework:** What is the official HUD definition?

❖ Question about timing of the Shelter Redevelopment Schedule

- Do we have to wait for shelters to be redeveloped one at a time?
- Is a lesson learned that we shouldn't be redeveloping all of the buildings at once?
- Do we want to be redeveloping/replacing non-congregate shelters? **Congregate buildings are single purpose and if we misunderstand the demand/projections then we are potentially stuck with single-purpose buildings?**
 - ✓ We have a different program design for families vs singles because the FRSP model of progressive engagement model has an impact on the family side.
 - ✓ We have doubled the size of RRH on the singles side but it's not really practical to maximize RRH into a progressive engagement model before we have made good use of the PSH vouchers and housing resources on hand!

Question: what is an agile design that allows for multi-purpose buildings/uses?

Potential Discussion Questions:

- ❖ What are the current processes and pathways to shelter?
 - Is there an ideal? What is ideal?
- ❖ What are the current pain points in our system that we want to address with the shelter (re)design process?
 - FDBK: we have beds for the older medically vulnerable individuals at 801; I think it's 41 beds. Is that sufficient? Should we be looking to double those beds (80 beds) or should it be triple, quadruple that number?
 - FDBK: what is our plan for all aging individuals?
- ❖ **How do we design a shelter system that supports and is focused on exit to housing?**
 - Begs the question, does our current system impede the focus on exit to housing and how?
 - FDBK: single shelter has not been designed as part of a system with housing and healthcare, so this is a most helpful perspective as a result of the pandemic and the efforts to integrate diversion and rapid exit at our LBS
 - FDBK: is it the shelter system or the housing placement process that impedes exit? There are larger system impediments but also pre-pandemic shelter operations and lack of HMIS visibility that was very difficult to work around.
- ❖ **What are must-have vs nice-to-have components and features of shelter?**
 - District is often asked to look at buildings as options to purchase for facilities
 - If one of the PEPV options could be transformed into a permanent housing type, would that work?
 - FDBK: there is a co-hort of people who may be willing and interested to stay in a situation like
