Meeting Notes

I. WELCOME AND AGENDA REVIEW

Theresa Silla (Executive Director, ICH) welcomed participants and opened the meeting by

- Recognizing the committee co-chairs (Christy Respress, Executive Director, Pathways to Housing) and Rachel Pierre (Interim Director of DHS),
- Reviewing the meeting agenda,
- Provided a review of ICH meeting conventions and management of meeting notes and the listservs.

Theresa Silla (ICH) provided an update that Rachel Pierre is now Acting Director of DHS while Director Zeilinger is on sabbatical and will also be serving as Acting Co-chair of the Executive Committee in her absence.

Rachel Pierre (DHS) welcomed the group, noting that her acting term will end in September 2023.

B. ICH UPDATE

Jose Lucio, Chief of Contracting and Procurement at TCP, provided an update on the 2023 HUD Continuum of Care (CoC) Program Notice of Funding Opportunity (NOFO). The NOFO was released July 5 with the full application due to HUD on September 28. Please see slides 19 – 23 in the PPT for details.
