C. DHS

Anna Fogel (Deputy Administrator for Permanent Housing for the Family Services Administration, DHS) shared her screen and walked through key data points related to the utilization of unit based PSH in the DHCD and DHS Pipelines. Please see slides 23 – 26 for the data sets shared during the meeting.

Comments, concerns, and questions from the discussion are captured on slide 18. Topic areas are summarized here for easy reference:

- Request for historical data to better understand trends across recent years.
- Request to facilitate move-on from PSH-specific resources to mainstream affordable housing resources so that PSH resources can be reserved for individuals who need the wrap-around services offered via PSH.
- Importance of seeing the same data points for the CoC pipeline that is managed by TCP, in addition to the data points for the DCHD and DHS pipeline presented.
- Need to understand turnover across unit-based resources better.

D. ICH
