### **Meeting Summary:**

### 1. DC Government Agency Updates

#### DHS

- DHS programs will continue modified operations in Phase 2; different metrics are used to re-open congregate spaces like shelters
  - Street outreached was reduced due to COVID; returning to full staffing July 1; will be able to devote more time to housing focused work
- Will talk more about re-opening plan (including COVID testing at emergency shelters) during partner call Friday, June 26 at 2pm
- Focusing on Pandemic Emergency Program for Highly Vulnerable Populations (PEPV) sites and other programs in hotels; looking to speed up housing matches
- Awarded \$23 million in ESG funding from HUD; much will go to addressing spending pressures

#### DHCD

- All programs operating; will continue with agency-wide telework
- Budget hearing last week; \$100 million investment in Housing Production Trust Fund remains
  - Markup will be Wednesday, June 24 at 12pm
- Advocating for more federal resources; several pending national legislations that address additional COVID recovery funds, including fund for rental assistance and new infrastructure bill w/ significant housing component
- \$11.3 million dollars in CARES act; most going to rental assistance, DHCD stepping up two rental assistance programs
- Friday announcement of the COVID-19 Housing Assistance Program (CHAP), a \$6.2 million program for low-income renters that can provide up to three months of rent arrears since April 2020

- Program income limits go up to 80% MFI
- DHCD will direct approximately \$2 million to Housing Counseling Services, Greater Washington Urban League and United Planning Organization
- Will be complementary to the DHS Emergency Rental Assistance Program (ERAP)
- Worked with John Wall Family Foundation to set up housing assistance for Ward 8 residents; raised \$600K and being administered by Lydia's House and Housing Counseling Services
- Continued small business assistance in Wards 7 and 8
- Set aside \$2 million for non-profits capacity support program; grants program for non-profits engaged in housing or community development, looking to help those impacted by COVID with increased expenses
- PSH pipeline report is being updated and will be circulated to the Committee

# DCHA

- DC Phase 2 does not introduce many modifications for DCHA operations
  - Still teleworking, handling emergency work orders and continuing initial and emergency inspections
- Will be launching customer service center at headquarters
- Continuing with re-certifications; changes in income must be reported to Housing Authority

- Focus on Projects deemed priorities for the year
