- Permanent Supportive Housing
- Rapid Rehousing
- Joint TH and RRH

The CoC Ranking Committee selected one project application to submit for the Permanent Housing Bonus project two projects for the Domestic Violence Bonus project:

- TCP's Role: To solicit applications for the bonus opportunities.
- ICH's Role: Assemble a Ranking Committee that will select the applications and rank them along with the renewing projects.
