Meeting Summary:

1. DC Government Agency Updates

DHCD

• Mayor Bowser has formed a Rental Strike Force coalition, composed of tenants, housing providers and other stakeholders; will examine housing rental market for

both immediate needs in wake of COVID as well as broader rental housing market; details of strike force composition will be detailed in Mayor's Order coming later this week; will have meetings open to the public; will draft recommendations for District government actions

- The December Federal Relief Plan allocated \$200M dollars to the District; received "state" share of relief funds; DHCD, DHS, DMPED working to comply with Treasury Department guidelines; the funding will continue to serve District residents; funds can be used to cover past arrears and payments moving forward; priority on 50% AMI and below; both tenants and housing providers can apply
 - o Continuing to receive and review applications for ERAP and CHAP
 - Hoping to use relief funds for new program focused on energy assistance / energy bill arrears
 - o Current rental relief resources listed on https://coronavirus.dc.gov/rent
- The Biden Administration has submitted several new relief plans, one of which
 includes a provision that would fund conversion of certain commercial real estate into
 housing for homeless individuals and families; important to advocate for the District
 receiving a "state" share; DHCD will continue to track this and report out in future
 Committee meetings
- A new Federal policy change has fixed the level of the 4% Tax Credit, which means that additional equity is now available for all projects utilizing 4% credits; this reduces the amount of gap funding DHCD needs to put into projects. The increased tax credit equity should have a substantial impact on the District's ability to accelerate the schedule on pending projects in the pipeline, and also provides an opportunity to perhaps move other projects forward from the wait list. DHCD staff is currently analyzing the pipeline to determine potential next steps.
- Will have fuller update on potential funding and Section 108 status at February Housing Solutions Committee meeting
- The Mayor's budget is due to be submitted last week in March; the DHCD oversight hearing at the end of March, and the agency's budget hearing is currently scheduled for May 4

DCHA

- DCHA recently met with representatives of The Way Home Campaign to identify and address delays in the lease-up process; this conversation is continuing.
- Will address outstanding questions from the December Housing Solutions Committee meeting in a separate follow up document

DHS

• Will address outstanding questions from the December Housing Solutions Committee meeting in a separate follow up document

2. Report out on PEP-V "Sprint"

- Since December 1
 - o 41 clients have moved out of PEP-V with a PSH/TAH voucher
 - o DCHA has approved 154 PEP-V client applications
 - o 103 people are currently searching for a unit
 - o Clients selecting units and leasing up each day
 - O DHS Housing Navigation team is showing units to clients each day and have hosted 6 Meet and Lease events at PEP-V sites over last month; over 20 people selected units at last week's Meet and Lease events and are currently filling out lease up paperwork
 - DHS and DCHA are currently reviewing outcomes from the last two months and looking at how they can create long lasting changes to speed up the lease up process
 - Question how many of 154 placements involved 2020 resources
 - Request for greater transparency around this review; ask for more concrete actions steps on how to address and escalate questions around issues that have delayed the lease-up process

3. **Updates on Committee Task Groups**

• PSH Production Task Group held kick off call after the December Housing Solutions Committee meetings; there have been two focus groups of developers in January; the co-chairs working on finalizing recommendations with the goal of presenting at the February Housing Solutions Committee meeting

4. Committee Co-Chair Selections

- Chapman will be transitioning out as the Committee Co-chair; will assist with the transition to the incoming Co-chair
- Reginald Black (People for Fairness) and Shellon Fraser (CSH) are candidates for the open Co-chair seat; email sent out from after meeting with link for Housing Solutions Committee stakeholders to cast their vote. Result will be sent out by ICH email.
