VII. Announcements

- The National Law Center on Homelessness and Poverty and Baker McKenzie will release a scaled-back version of the Homeless Youth Handbook. The document will be launched on October 23rd electronic version. The chapters released will focus only on legal rights and legislation. Following the launch, Phase 2 of the project will ensure that youth with lived experience and community stakeholders guide the creation of additional chapters and resources.
- OSSE will facilitate the 2019 National Association for the Education of Homeless Youth Conference in November 2019. Nicole Lee-Mwandha (OSSE) will send information to those wanting to participate.
- DBH Our Time reports that DBH's youth council is looking for new committee members. DBH is also holding a job/resource symposium, followed by a gala, October 26th. There will be an award ceremony that will highlight youth who meet criteria as well as adult allies.
