- CAHP Prioritization Kimberly Waller framed the conversation by reviewing the various CAHP systems as well as reviewing a slide on resources available for FY21 for Permanent Supportive Housing. Eric Schneider talked about the prioritization for singles for permanent supportive housing. Lindsay Curtin then spoke through the prioritization of singles for rapid rehousing as well as prioritization for veterans. Darrell Cason then reviewed prioritization for families for PSH and FRSP. Kimberly said that the family system is also looking at some policy focus areas for the upcoming year, including creating a CAHP dashboard, tracking turnover in vouchers, using case conferencing, targeting site-based programs, and working with the domestic violence system. Kevin Bauer and Michelle Maringe then reviewed the youth CAHP prioritization, which includes an updated Manual.
- Point in Time methodology Tom Frederickson from the Community Partnership reviewed initial ideas about the upcoming Point in Time (PIT) Count and asked for feedback on them. HUD has not yet provided guidance on whether to cancel PIT in 2021 due to COVID.

Updates

- Next steps on Homeward DC 2.0 Kristy Greenwalt gave a heads up that the next version of Homeward DC 2.0 will come out between about November 3 and 10th and she asked for quick feedback. The Plan would then be reviewed at the November Strategic Planning Committee meeting with the goal of approval at the December Executive Committee meeting.
- OCOG Diversity, Equity and Inclusion progress Kristy also shared that the Council of Governments is working on putting out a Request for Proposals for a consultant. They are pulling together a technical selection committee who will review proposals and make a recommendation to COG. There is also a technical advisory committee if there are people interested in providing feedback. Anyone interested should email ich.dmhhs@dc.gov for the technical assistance committee. The hope is to have a consultant identified early in 2021.

Priorities for 2021 for Homeward DC – Kristy asked for feedback as to the top priorities related to Racial Equity for 2021. Due to time constraints, Kristy said we will recirculate the matrix and ask for feedback via email. She also asked for feedback if there should be a standing workgroup or if there should be smaller project teams. Reginald Black suggested focusing on income and data from the office of Planning. Kelly Sweeney McShane said it would be important to have a group taking a lead, but also incorporating it into the work of all the committees. Kristy said one idea was to have a list of questions that every committee should be looking at to keep racial equity at the core of our work.
