- Welcome Kelly Sweeney McShane welcomed the committee and provided an overview of the agenda which will focus on the family system. Next month, we will focus on the systems for individuals.
- Presentation on Calling All Sectors Initiative Makeda Vanderpuije from the DC Office of Health Equity reviewed a presentation on findings of a survey of providers about the intersection of pregnancy and homelessness. There was a conversation about how to better support people who are pregnant, including looking at policies and training for providers. Next steps include summarizing data from provider focus groups as well as focus groups with clients.
- Family System Workgroup Updates Kimberly Waller then reviewed the different workgroups that are focusing on families issues.
- FY22 F-CAHP Prioritization Eileen Rosa from TCP introduced Tracy Coleman who is the new Family CAHP Coordinator. Eileen then reviewed the prioritization recommendations for F-CAHP.
- Family System Overview and Updates Noah Abraham from DHS then provided an overview of the many changes going on within the family system. Topics included STAY DC, Rapid Rehousing, DC Flex, different housing voucher programs, and the shelter program. Slides are attached. In terms of STAY DC, DC has spent all of the funds and has requested additional money from the federal government. In terms of permanent housing vouchers, Noah said that there are more than 800 vouchers available through Permanent Supportive Housing, Emergency Housing Vouchers, and Targeted Affordable Housing. Noah said that, in terms of short term family housing, the number of families in shelter are very low. Hence it is hard to predict what will happen in the Winter, but the Winter Plan assumes a 50% increase in inflow each month above the average from the last three years.
