



- * CAHP has continued making matches and youth are being housed



Youth System Meetings During COVID

- * Youth CAHP has continued making matches and housing youth throughout the crisis
- * Youth Street Outreach, Drop-In Centers, and Shelters meet every other week
- Youth CAHP Policy meets monthly
- * Youth Covid-19 Provider Response Calls every other Thursday and are provider lead
- * DC Supporting Hopeful Youth Youth Action Board meets at least twice per month

FY21 Budget



- The financial impact of COVID-19 requires us to make sacrif while maintaining the critical services our residents expect and protecting our most vulnerable neighbors.
- The District has already taken steps to reduce spending in the current (2020) fiscal year by implementing a hiring and spending freeze across government.
- In the District's FY 2021 budget proposal, we are finding ways to save resources so that we don't lose ground on our shared progress in the District and progress made on Solid Foundations DC
- DC is leveraging federal resources to help respond to this unprecedented need

- * DC SHY meets at least two a month (shifted to a virtual platform)
- Developed By-Laws
- * Recruited new members
- * Established Workplans and Priorities



YAB & YHDP Fellow Updates

* DC SHY Priorities include:

- Develop policy and protocol recommendations to improve the youth system (both federal and local)
- > Support youth experiencing homelessness to exercise their right to vote
- Partner with Regional Youth Action Boards (DC SHY has virtually met with Baltimore's YAB, PG County's YAB, and more)
- Connect with Higher Education Institutions and develop strong partnerships with Leadership and Student Body






Remember the Youth Homelessness Demonstration Project Grant

 We have some important updates

- Congress passed legislation that extended the grant by a year this means we have more time grant out the \$4.28 million to the youth system
- > New proposed timeline for RFP release:
 - ✓ Release RFP January 11, 2021
 - ✓ Pre-Bidders Conference February 1, 2021
 - ✓ RFP Applications Due February 22nd
 - ✓ Review Panel/Process from February 23rd through March 26th, 2021
 - New review process
 - Tentatively 2 weeks for review; 2 weeks for interviews
 - Include Youth Action Board members and other non-conflicting stakeholders

Total Number of Youth CAHP Matches as of 4/22/20:

Breakdown by Months (2020):

- January: 40 Matches, 4 Still in Progress, 24 Move-ins, 12 Unassignments (Pre COVID)
- * February: 31 Matches, 2 Still in Progress, 20 Move-ins, 9 Unassignments (Pre COIVD)
- * March: 26 Matches, 3 Still in Progress, 9 Move-ins, 14 Unassignments (During COVID)
- * April: 21 Matches, 4 Still in Progress, 9 Move-ins, 8 Unassignments (During COVID)

Total: 118 Matches, 13 Still in Progress, 62 Move-ins, 43 Unassignments






Total Number of Youth CAHP Matches as of 4/22/20
