DHS Updates:


- Provided weekly through Friday DHS Provider/Partner Conference Calls
- Additional Updates:
 - ✓ Updated bathroom and hand washing station maps are on the DHS Website
 - ✓ Laundry has started at shelters and laundry trailer has been acquired
 - √ Showers/charging for unsheltered individuals is being worked on

DBH Updates:

- ➤ CRT
 - Is continuing operations as normal and has been identifying hotspot areas, handing out waters, and working to get individuals interested into both mental health and substance use treatment.
 - ✓ Is still responding to crisis throughout the city.
- DCOR teams
 - ✓ Are maintaining their usual schedule and working closely with the DHS outreach providers.
- Core Service Agencies (CSAs)
 - ✓ Many have moved toward regular telehealth contacts, although some are still providing in person services.
 - ✓ Are still open for intakes.
- ACT Teams
 - Continue to provide unaltered services and are providing both regular engagement and crisis response services. CSAs/ACT teams have been coordinating closely with CRT to better serve consumers.

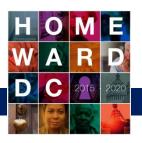

 - We will gain additional feedback today and then an updated work plan will be reviewed by the Executive Committee in May.








