- DHS PSH and Medicaid Progress Dena Hassan from DHS provided an overview of the transition to Medicaid for Permanent Supportive Housing. - FRSP program updates Noah Abraham and Maddy Solan from DHS provided an update on upcoming changes for FRSP. Noah said that they are working on a communication strategy to share information for clients, providers, and the community. Maddy shared information on the transition to Greater Washington Urban League's role in managing rental payments and inspections. Maddy also said that DHS is working on updating the IT systems as well as the FRSP regulations by October 1, 2022.
- Upcoming solicitations Tom Fredericksen from TCP shared an update about the two NOFO opportunities from HUD, including renewals (due Friday) as well for Unsheltered Supplemental NOFO. Anyone who is interested in the supplemental NOFO should let TCP know as soon as possible, as materials are due Sept. 30. - Other updates
 - Monkeypox Maddy prevented an update on monkeypox response, thanking TCP, DHS, and DC Health. The focus currently is on prevention. DHS is asking all providers to print out the information on monkeypox. DHS has also trained peer educators who were working on COVID so they can also talk about monkeypox. The presentation includes who to contact if there is a suspected case or to get more information on vaccines.
 - Partner updates Gary Maring asked about the effects from the influx of migrants in DC and particularly as they come to Virginia Williams. Maddy said DHS is working in that area but does not have information to share at this time. Several people shared that there needs to be more communication on the need, that local funds are not being spent at this time to support the migrants, and to coordinate a response. There was further conversation and additional notes are included in the powerpoint.
