### Meeting Notes

#### I. WELCOME AND AGENDA REVIEW

Eileen Rosa (Special Advisor, ICH) opened the meeting and as an icebreaker, invited attendees to share their Halloween plans and favorite candy.

#### II. DISCUSSION ON CAHP PRIORITIZATION 6-MONTH REVIEW

Samantha Nolet (CAHP Coordinator, TCP) introduced and presented information for the Youth CAHP 6-Month Review, including data and information on Scope of the Review, Case Conferencing, Pre-Check, and Matching. See PPT slides 9 – 32 for details.

Comments, concerns, and questions from the discussion are captured on slides 33 - 36. Topic areas are summarized here for easy reference:

- Clarification on how youth who use adult shelter are included on Youth By-Name List.
- Question on the purpose of the By-Name List pre-check form and how it will be used.
- Discussion on low response rate of the BNL pre-check form to inform Youth CAHP matching. Only 27% or 64 of the requested 234 requests were completed by providers.
- Question on the makeup of youth programming by single, shared room, apartment style to inform client choice at the time of match.
- Question on if match outcomes differ from shelter or outreach to understand potential gaps in response and follow up.
