Welcome and Introductions

Allen Y. Lew, City Administrator, called the meeting to order.

Public Comments

- There is so much for DC to do with regard to repairing the education system in order to prevent homelessness among our youth
- Another attendee wants the ICH to address the issue of young people who are graduating from high school and can't read
- DHS has done a good job with Permanent Supportive Housing (PSH) for the most vulnerable populations; it's now time to help people who need help finding a job (non vulnerable populations)
- The District needs additional support for elderly citizens that are chronically homeless living in the shelters
- Another attendee would like to receive Housing Taskforce recommendations on how homeless services should be funded next year; need feedback from that taskforce on how we should spend the money (the taskforce has met often and the Mayor is currently reviewing their recommendations)
- One attendee acknowledged the Mayor for allocating \$100M towards PSH
- A Miriam's Kitchen rep posed the question as to where the extra money the Mayor is promising is going to be distributed

Summary of Pre-Meeting

Maggie Riden provided the summary of the pre-meeting, which focused on the services that are provided to youth that are homeless. A few highlights of the discussion included:

- Need to have an increased capacity in the youth shelters; emergency and transitional
- Family conflict resolution is needed
- Youth find trouble navigating the adult system in order to identify the resources they need
- Not enough respect given to youth when service providers interact with youth; it is discouraging to the youth and they opt not to return for services
- Youth under 18 receive a lot of support but once they hit 18, they are automatically expected to support themselves

 Truancy, being frustrated due to the stressors associated with meeting basic needs while trying to attend/excel at school – the government needs to look at strategies to address early indicators that contribute to homelessness

Operations and Logistics

- Program Monitoring report will be coming out soon
- Have been looking at successful communication strategies for getting information out about available resources for the homeless

Shelter Capacity

- Continues to monitor the utilization of single adult facilities
- Currently operating with its capacity on the individual side
- Only 66 families in hotels this year major improvement from last year
- Next meeting: Thursday, February 21, 9AM at SOME (71 O Street)

Youth Subcommittee

• One of the goals of this committee is to bring the issue of youth homelessness to the ICH table

PSH Committee

- MOU for PSH, which sets out roles of the agencies that will be administering the PSH program, is near completion and is being sent around for final signatures
- There is a consolidated RFP which will be part of the FY13 NOFA

Summary of FY14 Strategic Annual Plan Public Comment Session – The summary for this session was distributed at the meeting

- The ICH will ask for draft work plans from agency directors in April and will reconvene in June to draft a plan
- The plan will be approved before the next Fiscal Year begins
- Goals: reduce number of people who are homeless; reduce return to homeless, reduce the length of homelessness, increase income, etc.
- Some recommendations call for more resources, others called for continued or better use of resources
- Based on public feedback:
 - Creating permanent affordable housing by looking at Housing First and other resources; investing in rapid rehousing, looking at affordable housing in general
 - Looking at ERAP and how to tweak that and improve its processes
 - Central intake unit to assist homeless individual
 - Preserving safety net
 - Victims of domestic violence support
 - More focus on youth
 - Looking at Medicaid to fund supportive services
 - Looking at procurement issues

APRA DMH Merger

- Will take place around October 1; a new department in DOH will form that will comprise of both APRA and DMH in order to increase greater access to services
- Goal is to have information about the merger on DMH's website in the next 10 days
- The main vision for this merger is that regardless of which door a customer walks into, they will be screened for substance abuse and mental illness

Youth Homelessness Presentation

- A handout was distributed; the information will be made available electronically on the ICH website (www.ich.dc.gov)
- The discussion dealt primarily with unaccompanied youth (not heads of household youth)

What's Working Well

- Good programs are readily available to youth
- For youth 18-24, there is an array of services that are available
- Increase in beds for young families has also been very helpful

Current Scope of Need

- There are between 1,600 and 4,000 youth who have experienced homelessness in the City
- 497 of those were heads of household
- 5% of the DCPS population have been considered homeless at some point in the year
- Higher levels of truancy is associated with homelessness

Recommendations

- Effective strategies for prevention
- Look at factors that lead to homeless (eg. Truancy)
- Youth friendly referral and intake process
- Stable and strategic capacity investments through the continuum of care
- Streamline youth access to housing and other support services
- Need combination of channels to help youth link to services
- Increased capacity for emergency beds and traditional housing for both youth between 18 and 14, and for youth under 18
- All future capacity should be grounded in data to get a better handle on the types of services that are needed in the future

Overview of NY Ave Presbyterian Church

- Formed in 1859
- One of the most important decisions the church made was to remain in the City and build its current facility in 1951 in order to better service District residents
- Provides bus passes to people needing assistance to get to job assistance programs and job interviews
